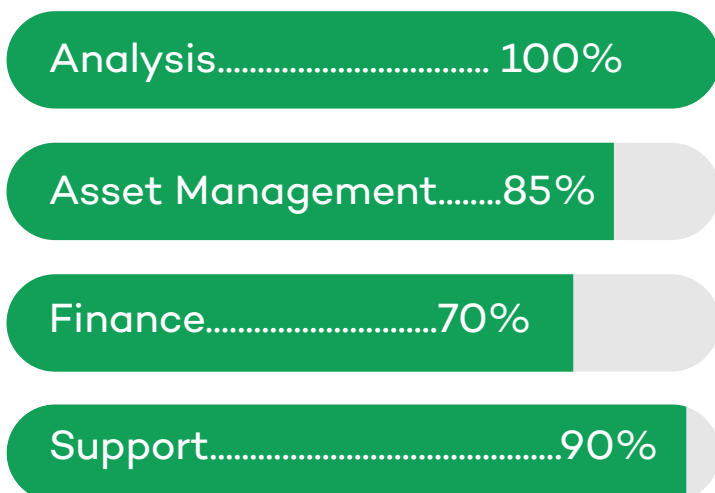
The developed Trading technology assumes medium load of the main deposit which excludes large financial losses and brings in profits due to successful scalping.

HOW CAN I MAKE A DEPOSIT?

In order for you to make deposit you will need to make a payment from your Bitcoin wallet. To do this on the website under "Create deposit" select one of the investment plans, enter the amount you wish to invest, choose cryptocurrency and click "Create deposit" button. Then follow instructions and send a payment from your wallet to our cryptocurrency address.

CAN I HAVE MULTIPLE, SIMULTANEOUS DEPOSITS?

You can make multiple deposits. The number of deposits that you can have at same time is unlimited. Each of your subsequent deposit will bring additional accrual. Note that each of your deposits will be separate with its own terms of accruals.

HOW OFTEN IS THE PROFIT ACCRUED?

Your profit accrued depending on your chosen investment plan – every 24 hours within a certain period or once at the end.

HOW FAST IS THE DEPOSIT CREDITED?
